HIGH GABLES HOMEOWNERS ASSOCIATION IMPORTANT MEETING NOTICE

July 12, 2006

Dear High Gables Homeowner,

As a result of the recent settlement actions in the case of High Gables vs. Oldham, the High Gables Home Owner's Association Board of Directors (BOD) is calling for a special meeting on Tuesday, July 25, 2006 at 7:00 p.m. The meeting will be held in the cafeteria at Chattahoochee Elementary School, 2800 Holtzclaw Road, Cumming, GA.

The purpose of the special meeting is to discuss two very important topics. First, the BOD will update High Gable's residents with current status and ongoing developments in the High Gables vs. Oldham legal action. Secondly, the BOD is recommending a special assessment of \$100.00 per lot, to be used to replenish the association's reserves which were mostly depleted to fund the legal action. The BOD strongly believes this action was in the best interest of High Gables and was necessary to protect and ensure the validity of our Covenants in the future. The BOD unanimously supports the special assessment, and; therefore, you will be asked to vote in favor of the special assessment.

While the BOD has acted in good faith at all times, including in reaching a settlement agreement with Mr. Oldham, Mr. Oldham continues to make unreasonable additional demands and has repeatedly threatened to sue the BOD members personally if the BOD does not agree to such demands. Most recently, he sent a ten-page certified letter to each director, demanding immediate resignation and calling a special meeting of High Gable's residents at which we would not appear, but delegate authority to him to conduct the meeting.

The BOD will not comply with Mr. Oldham's latest demands. The ongoing communication sent by Mr. Oldham is read, evaluated, and responded to in light of legal recommendations from two well-respected law firms. The BOD reviews all information to uphold our neighborhood's objective to maintain the covenants, protect property values, and provide a safe and friendly environment in which to live and play — for all residents. The BOD believes honoring any of Mr. Oldham's latest demands would jeopardize all future BOD abilities to fulfill their duties as set forth in the bylaws.

The BOD will provide information at the special meeting as to the timeline of events, violations incurred, and communication received and not received. We hope Mr. Oldham will also attend to provide his version of the matter as well as respond to your questions. We will have an independent party familiar with Robert's Rules of Order run the meeting to ensure it will remain civil in nature.

In every community, guidelines need to be set forth and validated through the support of its members. Your attendance at this meeting is of the highest importance. It is our sincere wish you will make it a priority in your schedule to attend.
